I am honored and excited to be here serving as the new Chair of Area. People think I'm crazy for being excited, but I am for sure... you may be aware I am into brief and efficient reports, so this may be one of my longer ones. I wanted to talk

about a few things that I am hoping to accomplish in the next couple years if I am here for that duration. One thing I think is that we have a new opportunity here because of the coronavirus to use technology in a way we have never before, such as using a combination of physical and Zoom meetings, and I'd like to talk about using things like the Website to increase the electronic stamp that Portland NA is making at this time. Region has been pushing some limits on getting NA updated electronically and we want to be aware of doing that as well. We have a fully functional website that is changing to our needs and responding to changes we have wanted to make, and it is exciting. I want meetings to refer to the website more and more for their needs. Also, we would like feedback on what you would like on the website. PR is always accepting suggestions on that.

Also, I have noticed that we have had some pretty challenging communication at times between subcommittees themselves, and between groups and subcommittees, as well as between officers, groups and subcommittees and we are trying to improve that, as Will re-instated the Communications Subcommittee and Molly is the Chair. What this means is that groups can go there to share not only what they are doing that is working, but also new ideas they have to get the message out, as well as to solve problems they are having by finding out how other groups are handling those problems and supporting each other. Also, the groups can influence their sub-committees easily here by telling the subcommittees what they need them to do for them.

Since the sub-committee's whole purpose is to serve the fellowship, we want groups to constantly be involved in telling Area what they need done to support them.

Also, there is a new section on the Website where Sub-committee Chairs will be going to list contact information, as well as list the open service positions they now have on those sub-committees and, hopefully, we can keep that up to date as well, with brief descriptions of what those positions involve. I think that might work to increase volunteering at this level. So if you are Doug, MacRae, Candace, Tommy or John A., please check out the new Service section on the website and update your information to Myk our webhost so we can see if that section is going to be helpful. This should not take you that long to do that at

porltandna.com and we would like to see that section filled in and see if it is effective for groups, members to use.

A lot of these things are in line with what Will started previously regarding the use of group reports in the Agenda to have as a way to hear directly from the groups, which is what Area is really intended for. As a result, we will still be having no questions during reports to the groups from sub-committees, as this will give us plenty of time to hear from our groups during the rest of the meeting. Many of your sub-committee questions can be answered by going to the website and getting the contact info for that sub-committee and then emailing them. I'm encouraging all sub-committee Chairs to see what email is on the website for them and to answer any emails in those accounts quickly. Also, we are always trying to improve attendance at Area by groups and hope to do that by word of mouth. If you know of a group that cannot attend, for any reason, please try to get contact information for them and we can at least send them the monthly minutes to keep them updated.

In an attempt to re-structure the new schedule that will be ever-changing in the near future, we are asking that you take the time to go the website and re-register your meeting (group) and tell us whether it is Zoom now, physical, or a combination of some kind. You may also tell us if a person needs to wear a mask there (e.g.) and we can list that for you as well. It's been a confusing time and we want information given out about your group to be an accurate as possible. We'd like to have an accurate schedule as meetings re-open and this is the only way we figured out how to ensure that. It should only take you a few minutes to do that. Also, because times are changing it would be helpful if each group would investigate getting their own bank account. Or use a member who has their own bank account to be trusted for that. Even paying for your Literature soon will probably be coming from your bank account.

Also, please keep in mind that the subject of the coronavirus itself and accompanying guidelines can be very divisive and please, at all times, have respect for people's individual opinions and personal feelings about what is happening at this time. We all want to be safe. So please try to understand that some members are getting their needs met on Zoom and some are not really. We are all different and we have different perspectives. Our main concern, of course, is that the newcomer is getting the message of recovery.

Also, I attended the Communications Sub Committee this month, Literature, and PR/Outreach. Janet and I went to open the main account at OnPoint, so that has been done. Also, I changed the Corporation paperwork to reflect elections, so now Theresa D. myself, and Janet H. appear on the corporation paperwork with the state.
